

2020 NOODLES & COMPANY SURVEY SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The 2020 Noodles & Company Survey Sweepstakes ("Sweepstakes") is sponsored by Noodles & Company ("Sponsor"), 520 Zang Street, Suite D, Broomfield, CO, 80021-8239 and is administered by Prize Logic, LLC ("Administrator"), 25200 Telegraph Rd., Suite 405, Southfield, MI 48033.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on January 1, 2020 at 12:00 AM Central Time ("CT") and ends on June 30, 2020 at 11:59:59 PM CT ("Sweepstakes Period"). The Sweepstakes includes the following six (6) monthly entry periods (each a "Monthly Entry Period"):

Non-winning entries will **not** carry forward into subsequent Monthly Entry Periods. Additionally all entries received in January, February, and March will combine into the "Quarterly Drawing 1", and all entries received in April, May, and June will combine into the "Quarterly Drawing 2", as set forth below:

There will only be two (2) Quarterly Drawings. The Administrator's computer is the Sweepstakes official clock.

2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

3. HOW TO ENTER THE SWEEPSTAKES: During the Sweepstakes Period, there are two (2) ways to enter the Sweepstakes:

A. Online Survey: An eligible entrant may purchase any food or beverage item from a participating Noodles & Company restaurant within the fifty (50) United States and the District of Columbia, visit www.feedback.noodles.com ("Website"), and follow the instructions to enter the unique code printed on entrant's Noodles & Company receipt, complete a survey, and provide entrant's complete first and last name, e-mail address, and phone number. After the completion of the survey and submission of entrant's information on the Website, an entrant will receive one (1) entry into the applicable Monthly Entry Period and one (1) entry into the applicable Quarterly Drawing (based on the date in which the survey is completed).

B. Mail-In Entry Without Purchase: To enter without making a purchase, an eligible entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, and date of birth (MM/DD/YYYY) on a 3½"x5" card ("Mail-In Entry") and mail it with sufficient postage to: 2020 Noodles & Company Survey Sweepstakes (PL013344), P.O. Box 251328, West Bloomfield, MI 48325. A Mail-In Entry must be postmarked by the Monthly Entry Period End Date and received by the Mail-In Entry Received by Date (as indicated in Section 1) to be eligible for the applicable Monthly Entry Period and Quarterly Drawing. If a Monthly Entry Period ends on a Sunday, the Mail-In Entry may be post-marked on the subsequent Monday. An entrant will receive one (1) entry into the applicable Monthly Entry Period and Quarterly Drawing for a valid Mail-In Entry. Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, Mail-In Entries mailed in envelopes or sent in excess of the entry limits set forth below will not be accepted. A Mail-In Entry received without a verifiable and legible return address will be deemed incomplete and not valid.

IMPORTANT: If using a mobile device to participate in the Sweepstakes, data rates may apply. Not all mobile telephone providers carry the service necessary to participate in this Sweepstakes. Entrants should consult their wireless providers' pricing plans.

Limit: Regardless of the method of entry, limit one (1) entry per entrant per Monthly Entry Period, and up to three (3) entries per entrant per Quarterly Drawing. Entries received in excess of the entry limit will be invalid.

4. RANDOM DRAWINGS: On or about each Monthly Entry Period Drawing Date listed in Section 1, the Administrator will randomly select ten (10) potential "Monthly Prize" winners from all eligible entries received during the applicable Monthly Entry Period. On or about each Quarterly Drawing Date listed in Section 1, the Administrator will randomly select one (1) potential "Quarterly Prize" winner from all eligible entries received during the applicable Quarterly Drawing. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

A. Monthly Prizes (10 per Entry Period, 60 total): Each Monthly Prize winner will receive \$100 ("Monthly Prize"). Ten (10) Monthly Prizes are available in each Monthly Entry Period. The ARV of each Monthly Prize is \$100.

B. Quarterly Prizes (1 per Quarterly Drawing, 2 total): Each Quarterly Prize winner will receive a \$1,000 ("Quarterly Prize"). Only one (1) Quarterly Prize is available in each Quarterly Drawing.

The ARV of each Quarterly Prize is \$1,000.

C. Total ARV: The total ARV of all prizes available during the entire Sweepstakes Period is \$8,000.

D. Odds of Winning: The odds of winning a Monthly Prize depend on the total number of eligible entries received during each Monthly Entry Period. The odds of winning a Quarterly Prize depend on the total number of eligible entries received during each Quarterly Drawing.

E. General: Prizes will be awarded via Chase Quick Pay. In no event will more than the above numbers of prizes be awarded. If, for any reason, more prize notifications are sent (or more claims are received), Sponsor reserves the right to award a prize through a random drawing from among all eligible prize claims received. An entrant may win both one (1) Monthly Prize and one (1) Quarterly Prize during the entire Sweepstakes Period. No prize substitution or exchange will be allowed, except by Sponsor, as provided herein. The Sweepstakes Entities shall not be held responsible for any delays in awarding a prize for any reason. If after a good-faith attempt Sponsor is unable to award or deliver a prize, the prize may not be re-awarded.

6. HOW TO CLAIM A PRIZE: Each potential winner is subject to verification of eligibility and compliance with these Official Rules. Potential winners will be contacted by Administrator via e-mail or phone call following a random drawing and will be required to provide their complete mailing addresses within three (3) calendar days of notification. The potential Quarterly Prize winners will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or the prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Failure to provide all required information and a signature on the documents within the stated time period may result in forfeiture of a winner's right to claim his/her prize, and may result in the prize being awarded to an alternate winner, if time permits. Any portion of a prize not accepted by winner will be forfeited. Federal, state, and local taxes on a prize and any expenses relating to the acceptance of and use of a prize not specified herein are the responsibility of a winner. A prize will be awarded only to a verified winner.

registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a Prize; or (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. DISPUTES: THIS SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF COLORADO, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN THE BROOMFIELD COUNTY, COLORADO. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JUDICIAL ARBITRATION AND MEDIATION SERVICES ("JAMS") IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN COLORADO. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN BROOMFIELD COUNTY, COLORADO. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE,**

EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
